Sub: Warning for Non-Compliance of Regulation 45(3) of SEBI LODR.

This is with reference to the Name change application submitted by the Company dated September 03, 2024 seeking Exchange's approval for changing its name from INDIAN BRIGHT STEEL CO.LTD. to AZAD INDIA MOBILITY LIMITED.

It was observed that the Company was in Non-compliance with Reg. 45 (3) of SEBI LODR and the Company had provided ratification letter in that regard. The application was processed and the details of non-compliance was referred to SEBI. It is observed that the Company is yet to ratify the non-compliance w.r.t Reg. 45 (3).

Further, SEBI has noted the non-compliance and has advised to inform the Company as under:

- 1. Company is advised to be careful in the future, exercise due caution and initiate corrective steps to avoid recurrence of such lapses in future by placing the warning letter and the corrective steps taken before the Board of Directors.
- 2. Disseminate a copy of the warning on the Stock Exchange.
- 3. Inform the exchange upon Ratification.
